## 2017 4-H FITTING AND SHOWMANSHIP JUDGES TRAINING CLINICS



The Massachusetts 4-H Horse Program will be offering 2 4-H Fitting and Showmanship Judges clinics in the spring/summer of 2017. These training clinics are offered to adults and youth ages 14 & older who wish to learn or review the rules and procedures for judging 4-H Fitting & Showmanship classes.

Participants who successfully complete the clinic and a written test will be eligible to be listed in the Massachusetts 4-H Fitting & Showmanship Judges List. Youth completing the clinic and written test will be qualified to assist judges or work as scribes, and will be listed on the Judges List as such. Because rule changes are made from time to time, all judges must attend a clinic and complete a test once every three years if they wish to remain on the judges list.
