Explanation of Terms Used in Judging-INDIVIDUAL

1. PARTICIPANT

- Appearance/overall impression: Appropriate for presentation, dress to enhance presentation topic (theme), in accordance with 4-H Dress Code. Overall demeanor and attitude should be pleasant and relaxed.
- Use of eye contact: Presenter should make eye contact with judges and others during the presentation and avoid looking strictly at posters or props.
- Voice projection: Should be loud enough to be heard in back of room, clear and calm.
- Poise and composure: Appears confident.
- Organized and resourceful: Should set up presentation on their own, or with help from fellow 4-H member. Must be prepared and able to start within a reasonable amount of time. How do they deal with unplanned problems/challenges during presentation?

2. CONTENT

- Topic suitable for presenter's age and ability: Subject should be an appropriate 4-H topic and not too challenging or easy for youth.
- Information adequate and research evident: Presenter should have prepared the right amount of information for the type and time of presentation. Should demonstrate he/she made an effort to research topic beyond their general knowledge.
- Relayed information and knowledge in an effective manner: Youth clearly presents information in a manner the audience can understand.
- Successful use of language and grammar: Did youth use correct pronunciation and speak in an understandable and effective manner?
- Presenter expresses enthusiasm for topic: 4-H member should show an interest in the topic chosen and have expanded his/her knowledge on the subject.

3. WORKMANSHIP

- Effective use of visual aids: Props and other items should be used to enhance their presentation.
- Posters are neat and legible: Can be clearly read from a distance and are not too wordy or cluttered.
- Size appropriate graphics and illustrative materials: Can be clearly seen from a distance and distinguished from other information.
- Accurate spelling: whether a computer was used or not, correct spelling should be present.

4. DELIVERY

- Organization of presentation: Has three distinct sections; introduction, body and summary.
- Creativity and originality: Presenter has come up with a creative way to present the topic including an imaginative introduction.
- Points presented in a logical sequence: Presentation should flow in a comprehensive way.
- Effective use of time: Time limit for juniors is 3-10 minutes, for seniors 7-10 minutes. Youth should spread information out appropriately based on topic and age.
- Ability to answer questions from the judges: Youth should repeat the question and provide a response. It is acceptable for the youth to respond that he/she does not know the answer.
- Appropriate use of notecards: This is based on the age and experience of presenter. Seniors are highly discouraged from using note cards at the state level. If notecards are used, the presenter must maintain proper eye contact with audience and use the cards as notes, not read the presentation from them.

INSTRUCTIONS:

- ▣ Each participant may enter one category only.
- ▣ 4-H Visual Presentation categories are divided into three age divisions (age determined Jan. 1):
Cloverbuds, ages 5-7 Juniors, ages 8-13 Seniors, ages 14-18
- ▣ Cloverbuds may enter at the county level; they may not participate at the state level.
- ▣ Pre-registration is required for county competition; only those selected at the county competition may compete at the State Visual Presentation Day. Youth selected for state competition will be notified by their 4-H Educator and the 4-H Educator will register them for State Visual Presentation Day.
- ▣ **Only seniors may compete in Projection Categories, PC1, PC2 and PC3.** A presentation that uses PowerPoint, Prezi or any other method of electronic projection must be entered in one of these categories. *Important: Member must provide all equipment he/she needs including the projector.* Internet is not available in the room.
- ▣ Weapons, live animals, lighters/matches/fire are not allowed. When in doubt, ask your Educator.
- ▣ Audience participation (including parents) and/or coaching from the audience is prohibited.
- ▣ Use of any projection or video clips (on laptop or any other device) in a VP category is prohibited.

Important reminder: tri fold boards are not allowed. They are not appropriate for presentations in a large room where people need to read the posters from a distance; this format is different from a science fair. Use standard size poster board (22' x 28") and make lettering and graphics large enough to read/seen from 10-20 feet. Foam core is the best type to use; you may use both sides of the boards. We recommend 4-8 posters, depending on the length of presentation. The posters are for presentation highlights only and the entire presentation should not be on the posters.

HELPFUL INFORMATION:

- A table and easel are provided – bring all other items that you need. You should provide a table cover if you will be using the table.
- ▣ Notecards are allowed but participants should not be reading their presentations.

JUDGING AND JUDGES:

Junior and senior 4-H members are judged using the Danish system; this means each presentation is judged on its own merit using a specific set of criteria. Each is awarded a blue (excellent), red (very good) or white (good) award. Cloverbuds are not judged competitively and each presenter receives a Cloverbud ribbon. All presenters receive feedback from the judges. This feedback is intended to assist the member improve future presentations.

At State Visual Presentation Day the presentations awarded a blue Danish are considered for a rosette; blue (1st) and red (2nd) rosettes may be presented in every category. Danish ribbons are presented in the classroom.

Rosettes are announced and presented during the afternoon awards program held in the auditorium.

Judges are provided with criteria and judging sheets, and are trained and oriented for this activity. We must all understand that there is still some personal judgment involved in the judging process as each person sees things in a unique way.
