



The Bristol County 4-H Association is pleased to announce that it is offering a \$500 scholarship in memory of Connie Agrella. & Ford. The scholarship will be available to any active Bristol County 4-H Member in his/her senior year of high school or currently enrolled in an institution of higher education and have not reached his/ her 21st birthday as of January 1 of the current calendar year. This scholarship will be awarded at the recipient's high school graduation or other appropriate occasion. The requirements for applying are as follows:

- Applicant must be an active member of the Bristol County 4-H Program for at least 3 years.
- Applicant has been accepted in a college program or to a school of higher learning or currently attending a school of higher learning.
- Applicant must show 4-H participation, leadership, citizenship, and awards/recognition. In addition, applicant must show involvement in education (such as high school, college/higher education institution, home schooling, GED), extracurricular activities and outside interests, such as church, clubs, sports, music, etc.
- Applicant must submit a brief essay on this topic: "How 4-H Has Prepared Me for My Future Endeavors." This must be in maximum of 12 Font and one (1) typewritten page, double-spaced.
- Applicant must submit a high school transcript, or equivalent, if home-schooled or GED student. A student of higher education must submit the same equivalent.
- Applicant must submit a copy of an acceptance letter to an institution of higher learning or proof of continuation in an institution of higher education.
- Applicant must submit a copy of the first semester's grades and proof of continuing education to receive the scholarship monies in January after receiving scholarship.

A panel of three (3) judges will review all applications. Applicant's name will be concealed.
