

Hampden County Improvement League Youth Agricultural Development Grant Application

Promoting Family Life through Youth and Agriculture

Grant Criteria

1. Applicants must be between the ages of 13 to 21 as of January 1st the year in which they apply.
2. The applicant must show current or previous involvement in an agricultural endeavor, is a member of a farm family or 4-H club (verification necessary).
3. The applicant must be a resident of Hampden County for a minimum of two years.
4. The applicant must provide proof of acceptance into requested program support or validation of the competition they are planning to attend.
 - a. A letter from coach or 4-H/FFA advisor is accepted.
5. The applicant must fully complete all materials required for submission for the grant.
6. Applications and pertinent information must be submitted electronically any day from January 1-September 1 each year. Any information received after that day will be not be considered. No exceptions will be made.
 - a. HCIL will be using 2023 as a project year to anticipate when programs become available to youth to qualify for this grant.
 - b. **Please submit within 30 days of receiving notification and accepting attending the program.**
7. Recipients of the grant will be notified within 15 days of the committee review.
8. No awards shall be made if, at the discretion of the scholarship committee, no applicants are properly qualified.
9. Each application will be required to submit a complete budget for the program in which they request financial support. The budget details are outlined in the application.
10. Grants shall be payable directly to the applicant. No funding will go to a parent or guardian. Grants will be in the amount deemed appropriate from the Youth Development Committee.

Applications are due March 1st each year and will be awarded by April 1st.

Each applicant can only receive financial support one time for a specific program. Other similar programs in the future, if awarded, will be considered but not guaranteed depending on the applicant pool for the current year for any previous recipients of the grant. This will be at the discretion of the HCIL current Youth Agricultural Development Grant Committee.
